## WHO WE ARE

The Centre for Innovation Management Research (CIMR) is a College-wide research centre. Launched in 2008, its members are drawn from a variety of disciplines, from Management and other social sciences to Computer Science and Biology. Thematically it encompasses science, innovation and technology systems, intellectual property rights, markets, social capital, entrepreneurship, globalisation and gender in both theory and practice. Analysis and communication of the implications of our research for policy-making (for governments and businesses) are central to the Centre's activities.

CIMR's members belong to four categories. The strength of the Centre comes from their interactions:

<u>Academic staff</u> are the core members of the Centre. They are responsible for the advancement of one or more of our specific research themes. They publish cutting edge articles in the world's leading journals and work closely with stakeholders.

<u>PhD students</u> are an essential component in the Centre's membership. Their affiliation is based on their being either first or second supervised by a core member of the CIMR academic staff. In practice, this means those in the Management Department, however all PhD students who are supervised by CIMR academic staff are invited to attend – e.g. those in Economics, Computer Science and the School of Science.

<u>Visiting Fellows</u> are special assets for the Centre. They are colleagues who work closely with the CIMR. They include entrepreneurs, policy-makers, business people, academics in other UK universities, and academics who work outside the UK, including France, Germany, Ireland, Italy, Sweden and the US.

<u>Alumni</u> are former Masters and PhD students working in the field of innovation and entrepreneurship. They have varied career experiences. Their continued involvement brings current ideas and insights to our programme and several of them give guest lectures on our teaching programmes.



## FROM THE DIRECTOR

In 2023 CIMR continued strengthening its relationship with members, colleagues and partners. Over the year we can see six key highlights within our activities and portfolio:

#### 1. CIMR 15<sup>th</sup> Anniversary:

2023 marked CIMR's <u>15<sup>th</sup> Anniversary</u>. To celebrate this with our community, we held an hybrid event and two workshops on October 20th. It was a day of celebration, inspiration, insight, and networking as we looked back on CIMR's journey.

The first workshop focused on discussing the 'Future of Innovation and Entrepreneurship Studies'. Our distinguished panel of speakers included Professor Martin Meyer, University of Vaasa; Prof Tim Vorley, Oxford Brookes Business School; and Professor Muthu De Silva, Birkbeck, University of London. #### 2. Continued focus on Research and Impact

As well as the BEI School Impact grant to fund our CIMR Media and Engagement Officer 2024, in November 2023 CIMR applied for a Regional Studies Association Networking award with our international partners, Kogod School of Business, Vaasa University and UIC Barcelona. This would fund four events, one in each location. The decision is pending.



In November 2022 CIMR submitted an application to the UCL Bloomsbury and East London doctoral training partnership (DTP) https://ubel-dtp.ac.uk/groupings-and-pathways/. CIMR is entered under a pathway entitled Prosperity, innovation, technology and policy, which is led by UCL. CIMR has added a fourth training route, on 'Innovation, Co-creation and entrepreneurship. The announcement that the application was successful came in 2023.

Since the appointment of Gabriella in February 2022, CIMR has achieved an increased amount and range of traffic to social media profiles and website. This includes the number of LinkedIn followers which is now well over 500. New users on the website come from more countries and thence a wider international profile. Audiences have grown for CIMR events and our research and outreach activities because of high-quality promotion activities using various media channels.
